



On the Boticário Renegotiation Portal, there are two negotiation possibilities:

1. **Negotiate all open invoices**

In this mode, you negotiate all available invoices to be paid, whether they are due or not. For this mode to be enabled for installment payments, at least one invoice must be due. Otherwise, payment can be made directly through the original means..

2. **Negotiate only overdue invoices**

In this modality, you only negotiate invoices that are already due. You can negotiate them according to the current table.
